Please come to the 11<sup>th</sup> Annual La Crosse Log Rolling Open, to be held Saturday, July 16, 2011 at beautiful Memorial Pool in downtown La Crosse. Memorial Pool is located on the University of Wisconsin – La Crosse campus and is within close proximity to La Crosse restaurants, shopping, and hotels! Last year we welcomed 55 log rollers and 17 log boomers to the event and are hoping for an equally exciting and impressive turnout this year.

We will start amateur warm-ups at 10:00AM with log rolling competition beginning at 10:30AM. The boom run will take place at Waterford Valley in the early evening for elite boom runners, after completion of log rolling competition.

Log Rolling competition will begin at 10:30AM (10:00 Warm-Ups). The following is the order of events:

- U-13, Adult Sport
- U -17 (U-17 opportunities to roll-up into Elite Division will be limited to those having placed in the top 3 of the U-17 or Semi-Pro divisions at the 2010 LWC or in the U-17 2010 Super Series. All rollers are limited to competing in only one log rolling division within the La Crosse Open. )
- U-7, U-10
- Elite Log Rolling (Elite Rollers must check in by 12:30. We will allow for a 30-minute Elite warm-up before the Elite competition)
- Boom Run – Immediately following close of log rolling competition at Waterford Valley. You must be an Elite division roller OR be at least 18 to compete in the boom run (spikes required).

I agree to waive, relinquish, discharge, release, and covenant not to sue the United States Log Rolling Association, Inc., the International Log Rolling Association, Inc. or any of either entity's members, officers, directors, agents, employees, athletes, and volunteers from any and all claims of injury, damage, or loss that I, my minor child/ward, or other family member or kin may have or that may accrue to me or my minor child/ward arising out of, connected with, or in any way associated with the activities of the La Crosse Log Rolling Open.

I have considered that if this agreement were not as broad as it is, the cost for my and/or my minor's/ward's involvement as a participant or spectator at the La Crosse Log Rolling Open would be considerably higher, and as I do not wish to pay a considerably higher cost, I waive the right to bargain for different terms in this agreement.

I have read this agreement thoroughly and fully understand it and enter into it on behalf of myself, my heirs, next of kin, assigns, and personal representatives. No one has made to me representations, statements, or inducements that change or modify anything written in this agreement.
